**NOTIFICATION TO SHAREHOLDERS OF
VONTOBEL FUND – VESCORE GLOBAL EQUITY MULTI FACTOR**

Luxembourg, 5 July 2022

The Fund’s Board of Directors (the “Board of Directors”) would like to inform you that the assets of the sub-fund Vontobel Fund– Vescore Global Equity Multi Factor (the “Sub-fund”) have fallen to a level which no longer allows an economical and efficient management of the Sub-fund's assets.

As a result, the Board of Directors has decided to put the Sub-fund in liquidation as of 7 July 2022. No further subscription of shares in the Sub-fund will be accepted from 1 July 2022, 14:45 Luxembourg time, onwards.

The costs associated with the liquidation will be charged to the Sub-fund. Appropriate provisions were formed and are taken into account in the redemption price.

All liquidation and redemption proceeds that cannot be distributed to the investors shall, upon completion of the liquidation, be deposited with the Caisse de Consignation de Luxembourg until the statutory period of limitation has expired.

Investors are advised to consult their own legal, tax and/or financial advisors should they have any questions regarding the liquidation of the Sub-fund.
