### **NOTIFICATION TO SHAREHOLDERS OF VONTOBEL FUND – DYNAMIC COMMODITY**

Luxembourg, November 29, 2023

The Fund’s board of directors (the “Board of Directors”) would like to inform you that the assets of the sub-fund Vontobel Fund – Dynamic Commodity (the “Sub-Fund”) have fallen to a level which no longer allows an economically efficient management of the Sub-Fund's assets.

As a result, the Board of Directors has decided to put the Sub-Fund in liquidation as of November 29, 2023 in accordance with article 28 of the Fund’s articles of incorporation and section 22.5 of the Fund’s prospectus.

Subscriptions, conversions and redemptions of shares in the Sub-Fund will not be accepted anymore as from November 29, 2023, 14:45 Luxembourg time.

The costs associated with the liquidation are borne by the Sub-Fund and are reflected in the Sub-Fund’s net asset value.

Liquidation proceeds will be distributed as soon as practicable.

All liquidation and redemption proceeds that cannot be distributed to the investors shall, upon completion of the liquidation, be deposited with the *Caisse de Consignation de Luxembourg* until the statutory period of limitation has expired.

Investors are advised to consult their own legal, tax and/or financial advisors should they have any questions regarding the liquidation of the Sub-Fund.
