





Glossary

BetaA measure of sensitivity - given as the average percentage change in the price of a fund when the market (benchmark) rises or falls by 1%. A value over (under) 1 means that on average the fund exhibits more (less) volatility than the benchmark. The figure is calculated on a 3-yearly basis. IndexIs a characteristic portfolio considered representative of a particular market or a portion of it, and serves as a performance measurement for such a market. An index, or combination thereof, used as reference for performance comparison, is then called "reference index". Information ratio The information ratio (IR) is a ratio of portfolio returns above the returns of a benchmark to the volatility of those returns. Management Feels a fee which covers all costs relating to possible services rendered in connection with investment management and distribution. It is calculated by dividing the total net asset value of the fund (the value of the fund's assets less its liabilities) by the number of shares outstanding.
